PEDDLER LICENSE APPLICATION

Chapter 5.08 of the Middletown Municipal Code, sub-section 5.08.020 states: except as provided in sub-section B. (Non-Profit Organizations), no person may engage in peddling in the Town of Middletown without first applying for and obtaining a peddler's license from the Town.

Furthermore, sub-section 5.08.060 states: any person engaged in peddling in the Town of Middletown without a valid peddler's license shall be guilty of a misdemeanor, punishable by a fine up to \$1,000.00. In addition, any person engaged in peddling in the Town of Middletown without a valid peddler's license may be charged, at the discretion of the Burgess, with a municipal infraction for which the fine may be up to \$1,000.00 to be enforced in accordance with *Local Government* Article, Division II, Title 6, Annotated Code of Maryland (as amended from time to time). Nothing contained herein shall preclude the Town from seeking any other remedies available to it, either at law or in equity, including, but not limited to injunctive relief.
